## Development Management Policies Development Plan Document (DPD) -**Notice of the Proposed Main Modifications Consultation**

The hearing of the Development Management Policies DPD Examination took place on 10 May 2016. The Schedule of Main Modifications that is now being published for consultation takes into account suggestions agreed at the hearing. The Main Modifications are considered necessary in order to make the Development Management Policies DPD legally compliant and/or sound. It is emphasised that the consultation only relates to the Main Modifications and not to any other aspects of the submitted DPD. Crucially, this consultation does not represent an opportunity to raise other matters which either were, or could have been part of the earlier representations or the hearing on the Development Management Policies DPD. There is also no need to repeat representations that have been submitted before, which has already been passed to the Inspector.

For information purposes only the Council has also published a Schedule of Additional Modifications that will be incorporated into the DPD to enhance its quality. These Additional Modifications are not being consulted on.
