TRAVEL PLAN GUIDANCE

TRAVEL PLAN DEFINITION

A travel plan is a package of actions designed by a workplace, school or other organisation to encourage safe, healthy and sustainable travel options. By reducing car travel, travel plans can improve health and wellbeing, free up car parking space, and make a positive contribution to the community and the environment.

Travel plans are specific to a location and take into account the nature of the organisation, existing travel behaviour and types of journey people make.



POLICY BACKGROUND

National - Paragraph 36 of the National Planning Policy Framework sets out that all developments which generate significant amounts of transport movement should be required to provide a Travel Plan.

County - Surrey County Council is the Highways Authority for the Borough. Woking Borough Council works in partnership with Surrey County Council to achieve the aims and objectives of the Surrey Transport Plan, which sets out the transport strategy for Surrey.

One component of the Surrey Transport Plan is the **Travel Planning Strategy**. The aim of this strategy is to provide travel-planning measures, interventions and self help support to schools and workplaces in



Surrey to make informed choices about their travel.

Local - Woking Borough Council has an adopted **Core Strategy** that sets out the planning policy framework for managing development in the Borough. **Policy CS18: Transport and Accessibility** of the Core Strategy requires development proposals that generate significant traffic or have significant impact on the Strategic Road Network to be accompanied by a travel plan and a Travel Statement from smaller scale developments, in accordance with good practice guidance.

SCHOOL TRAVEL PLANS

The Surrey County Council School Sustainable Travel Team (SSTT) provide help and support for school travel plans.

A school travel plan identifies (STP) the journeys made to and from school and looks for ways these can be made safer and more sustainable. A STP is usually required when new facilities are built which increase the published admission numbers for the school.
