
All page, policy and paragraph references refer to the Woking Borough Council Site Allocations Development Plan Document and Proposals Map, Regulation 19 Consultation version, published for consultation on 5th November 2018. The examination reference for the DPD is WBC/SA/001, and the Proposals Map is WBC/SA/001A.

The Proposals Map is not defined in legislation as a development plan document, and the Inspector therefore has no powers to recommend main modifications directly to it. However, a series of modifications have been made to the map as it illustrates geographically the application of policies in the Site Allocations DPD. These modifications have been listed in the schedule below.



The allocation must include a location plan for the Traveller's Site.	Include new sub-site of 1.72ha labelled 'GB9A' within the site boundary to reflect extent of the allocated Traveller site (see Appendix F illustrating new sub-site).
PMM13	GB13: Brookwood Farm SANG	Accuracy, in response to comment	Amend site boundary in accordance with correct extent of SANG land (see Appendix G illustrating new site boundary)
PMM14	GB17: Woking Palace, Carters Lane, Old Woking	Following Inspector's recommendation during the Examination in Public. The policy is unjustified.	Remove designated 'Allocated Heritage Parkland' site, and replace with an amended site boundary depicting land within Council ownership only (see Appendix H illustrating new site boundary). Remove 'Allocated Heritage Parkland' from the key.
PMM15	GB18: West Byfleet Junior and Infant School Playing Fields (proposed to become GB11)	Clarity	Remove purple hatched area of 'Allocated Open Space'; designate only the school playing fields as 'Urban Open Space' and the school buildings as 'Urban Area' (see Appendix I illustrating new extent of designation).
PMM16	N/a	Update	Amend Green Belt boundary to align with Policy SA1 (see Appendix J illustrating revised boundary)


Appendix A: Revised plan of site UA34 (proposed to become UA33): Coal Yard/Aggregates Yard adjacent to the railway




Appendix B: Revised plan of site UA37 (proposed to become UA35): The Crescent, Heathside Crescent






Appendix F: Revised plan of site GB10 (proposed to become GB9 and GB9A): Land surrounding West Hall




Appendix G: Revised plan of site GB13: Brookwood Farm SANG
