Chris, I have reviewed my representations alongside the Inspector's identified issues for Matters 2 and 7 on which I am appearing. I do not propose to submit any further written statements on the basis that I will be entitled to elaborate orally on my original submissions in the usual way.

One point however I would like to clarify is that in my second Policy CS6 representation (regarding Woking STW, ref 307) I have noted a typo. My representation concludes: *"The final sentence of the policy is insufficient to overcome this problem."* To be clear this is intended to refer to the final sentence in the second paragraph of the policy, not the whole policy. I would be grateful if you would draw this to the Inspector's attention.
