STATEMENT OF ADOPTION FOR THE WOKING BOROUGH COUNCIL LOCAL DEVELOPMENT DOCUMENTS

AFFORDABLE HOUSING DELIVERY SUPPLEMENTARY PLANNING DOCUMENT (SPD), HOT FOOD TAKEAWAY SUPPLEMENTARY PLANNING DOCUMENT, AND COMMUNITY INFRASTRUCTURE LEVY (CIL) CHARGING SCHEDULE

Planning and Compulsory Purchase Act 2004 Town and Country Planning (Local Development) (England) Regulations 2012 Regulation 14 – Adoption of Supplementary Planning Documents Community Infrastructure Levy Regulations 2010 (as amended)

Regulation 25 Approval and publication of a charging schedule

- a) The Affordable Housing Delivery and the Hot Food Takeaway Supplementary Planning Documents (SPDs) were adopted by the Council and came into effect on 23 October 2014. The Community Infrastructure Levy (CIL) Charging Schedule was also adopted, it will be effective from 1 April 2015.
- b) The CIL is a means of securing developer contributions towards infrastructure provision in the Borough. The SPD documents provide detailed guidance for the application of specific policies of the Core Strategy. They do not introduce any new policies. They are a material consideration in the determination of planning applications.
- c) Any person aggrieved by the Affordable Housing Delivery or Hot Food Takeaway SPD may apply to the High Court for permission to apply for judicial review of the decision to adopt the SPD. Such an application must be made promptly, and in any event, no later than 3 months after the date on which the SPD was adopted.
